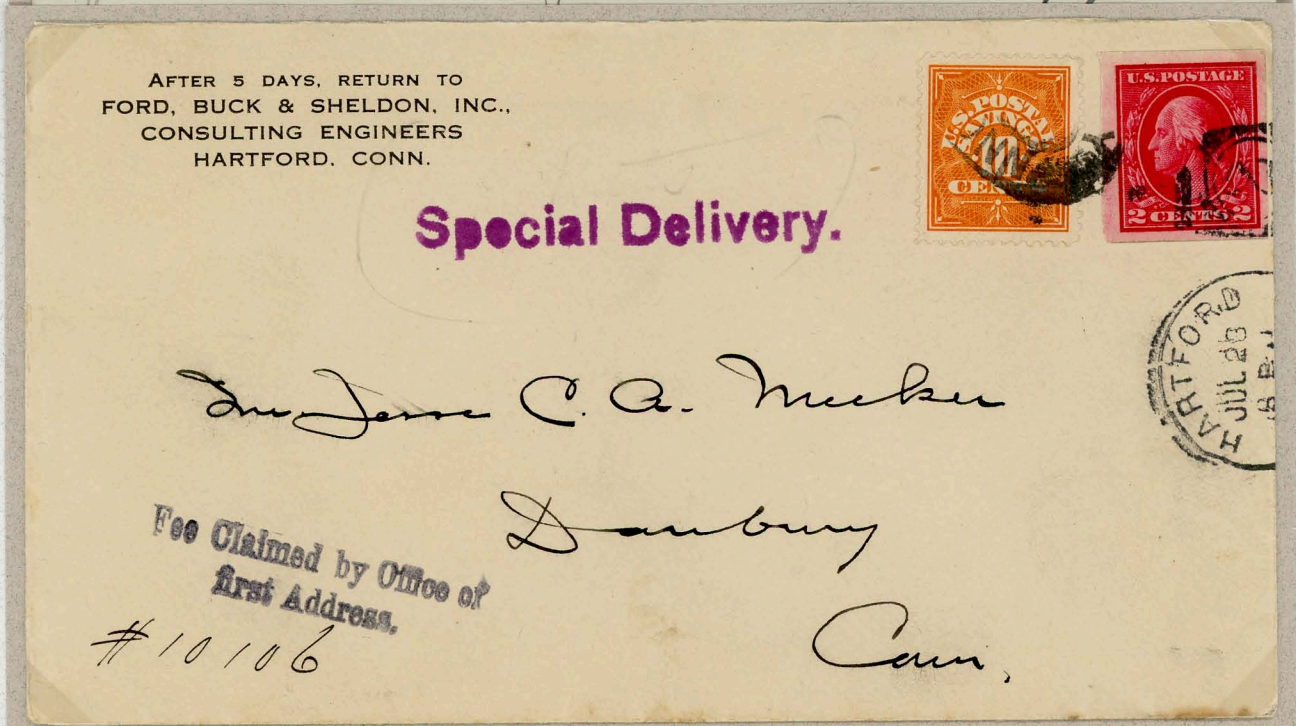

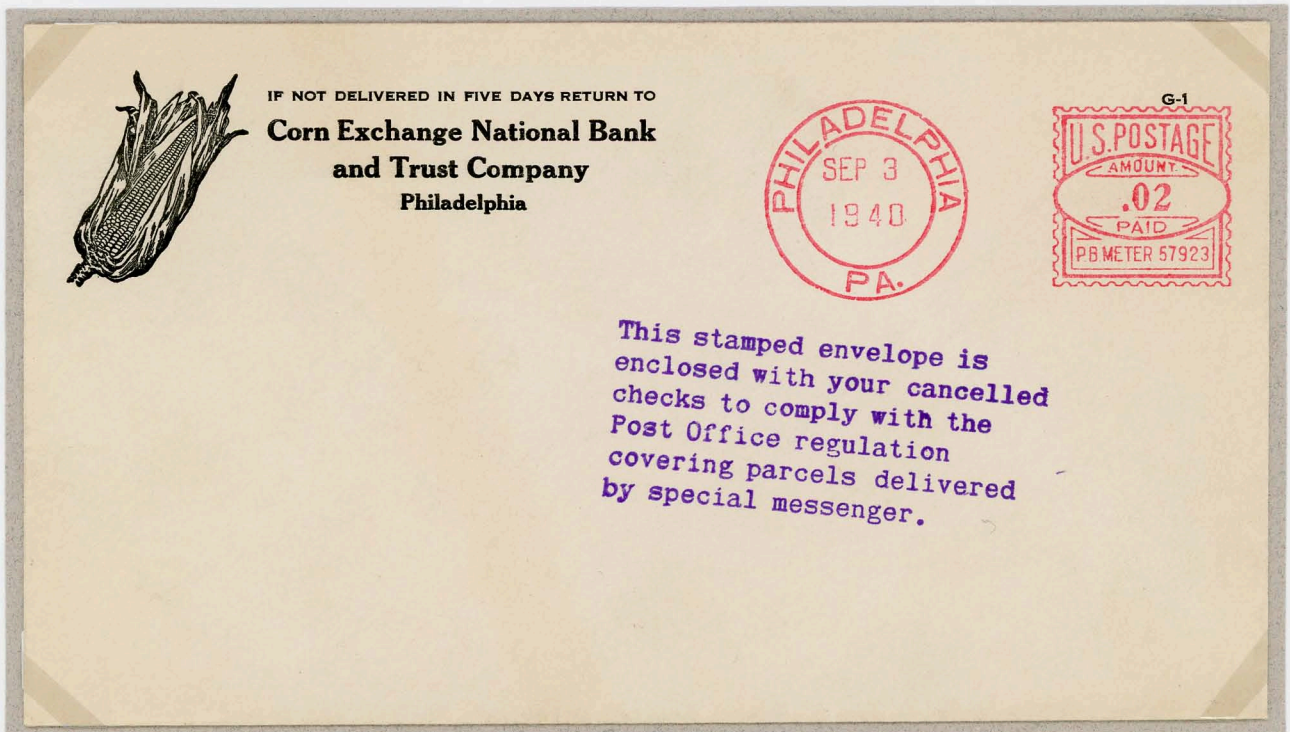

# Paying Special Delivery Fees

An Act of Congress allowed postage stamps to pay Special Delivery fees as of July 1, 1907.
